SCRIPPS HOWARD FUND

The Scripps Howard Award for Excellence in Audio Storytelling, honoring Jack R. Howard

WHO IS ELIGIBLE: Nominations may be made by individuals, news organizations or any interested party. This award honors the best in-depth and investigative audio reporting of a single event or issue. Judges will be looking for resourcefulness and complete coverage.

Commercially sponsored programs are not eligible unless the content is produced and editorially controlled by the news organization.

WHAT TO ENTER: Entry may be for a single broadcast or a series. Work must have originally aired or published in 2022 and must be entered as presented (with exception of advertisements). Entries are limited to 10 items (a day's presentation is counted as one item even if it includes several pieces). Supplemental material is welcome but must be clearly marked.

ENTRY FEE: \$75 Entry Fee

SCRIPPS HOWARD FUND

The Scripps Howard Award for Excellence in Breaking News

WHO IS ELIGIBLE: Nominations may be made by individuals, news organizations or any interested party. This award honors comprehensive and resourceful coverage of a breaking news event in 2022. Entries will be judged on general excellence, quality of deadline reporting and continuing coverage.

WHAT TO ENTER: Work must have originally aired or published in 2022. Entries should include reporting during the first 24 hours of an event and 3–5 follow-up reports. Entries are limited to 10 items (a day's presentation is counted as one item even if it includes several pieces). Broadcast content must be submitted as it originally aired to give judges an accurate viewing experience. Include script(s). Remove advertisements. Supplemental material must be clearly marked.

SCRIPPS HOWARD FUND

The Scripps Howard Award for Excellence in Business/Financial Reporting

WHO IS ELIGIBLE: Nominations may be made by individuals, news organizations or any interested party. This award honors outstanding business and/or economics reporting. This award encourages journalists to help educate the public about the free market economy, the business community, entrepreneurship, monetary policy, investing, money management or any related subject. It may be awarded for explanatory or expository journalism or investigative reporting. Results achieved by the reporting may be included.

WHAT TO ENTER: Work must have originally aired or published in 2022. Entries are limited to 10 items (a day's presentation is counted as one item even if it includes several pieces). Content must be submitted as it originally appeared (with the exception of advertisements). Supplemental material, which does not factor into the 10 item limit, must be clearly marked.

ENTRY FEE: \$75 Entry Fee

SCRIPPS HOWARD FUND

The Scripps Howard Award for Excellence in Environmental Reporting, honoring Ted Scripps

WHO IS ELIGIBLE: Nominations may be made by individuals, news organizations or any interested party. This award is given to encourage journalists to help educate the public and public officials on environmental issues. It may be awarded for explanatory or expository journalism or investigative reporting. Results, if any, should be included.

WHAT TO ENTER: Work must have originally aired or published in 2022. Entries are limited to 10 items (a day's presentation is counted as one item even if it includes several pieces). Content must be submitted as it originally appeared (with the exception of advertisements). Supplemental material, which does not factor into the 10 item limit, must be clearly marked.

ENTRY FEE: \$75 Entry Fee

SCRIPPS HOWARD FUND

The Scripps Howard Award for Distinguished Service to the First Amendment, honoring Edward Willis Scripps

WHO IS ELIGIBLE: Nominations may be made by individuals, news organizations or any interested party. This award honors an individual or an organization for distinguished service in the cause of the First Amendment guarantee of a free press, including but not limited to fighting the threat of censorship in America, overcoming public uneasiness with regard to press credibility, combating government secrecy at all levels, and instilling in the public an appreciation of its need as well as its right to know as guaranteed by the First Amendment. Judges will look for demonstrated dedication and perseverance.

WHAT TO ENTER: Entries may consist of articles published in print or online or broadcast materials, documentation of distinguished service or lifetime achievement, letters of recommendation or any other appropriate material. Submitted material may include elements published or distributed prior to or after 2022. Entries are limited to 10 items (a day's presentation is counted as one item even if it includes several pieces). Supplemental material must be clearly marked.

**The Scripps Howard Award for Excellence in Narrative Human-Interest Storytelling,
honoring Ernie Pyle**

WHO IS ELIGIBLE: Nominations may be made by individuals, news organizations or any interested party. This award honors storytelling that clearly exemplifies the warmth and craftsmanship of legendary World War II correspondent Ernie Pyle, who wrote movingly about everyday people with everyday dreams.

WHAT TO ENTER: Work must have originally aired or published in 2022. Entries are limited to five items (a day's presentation is one item even if it includes several pieces). Supplemental material, which does not factor into the 5 item limit, must be clearly marked. Single topic not required.

ENTRY FEE: \$75 Entry Fee

PRIZE: \$10,000 and a trophy

SCRIPPS HOWARD FUND

The Scripps Howard Award for Excellence in Visual Human-Interest Storytelling

WHO IS ELIGIBLE: Nominations may be made by individuals, news organizations or any interested party. This award honors visual storytelling that brings to life compelling stories about real people.

WHAT TO ENTER: Work must have originally aired or published in 2022. Visual stories will be judged on overall visual excellence and storytelling, whether the entry consists of a photograph essay, video story, a mixture of both or some other visual storytelling form.

Links to the story on digital is preferred. If that is not possible, place files in a folder on an online site of your choosing (i.e. websites such as Dropbox) and submit relevant links via our entry form. Entrants may submit PDF's of supporting material, such as pages on which their work appeared or links to photos published online. This is optional, not required. When labeling files, use your name and number them in the sequence you would like them to be viewed (i.e. "smith14"). Brief captions should be included for every photograph or video in a supplemental PDF document to provide context for the judges. Be sure to reference each photo or video's name with the captions you provide so judges can match them with the correct photo or video.

Entries are limited to 10 items (a day's presentation is counted as one item even if it includes several pieces). Supplemental material must be clearly marked.

The Scripps Howard Award for Excellence in Innovation, honoring Roy W. Howard

WHO IS ELIGIBLE: Nominations may be made by individuals, news organizations or any interested party. This award recognizes journalism that embraces new tools, channels, technologies and approaches or creatively uses established methods to provide better content and more meaningful experiences for consumers. It honors those who not only experiment with new methods of story gathering and presentation, but effectively execute these approaches and deliver works of impact.

WHAT TO ENTER: Work must have originally aired or published in 2022. Entries are limited to five items (a day's presentation is counted as one item even if it includes several pieces). Content must be submitted as it originally appeared (with the exception of advertisements). Supplemental material, which does not factor into the 5 item limit, must be clearly marked.

SCRIPPS HOWARD FUND

The Scripps Howard Award for Excellence in Local/Regional Investigative Reporting

WHO IS ELIGIBLE: Nominations may be made by individuals, news organizations or any interested party. This award honors substantive investigative reporting that covers a region or market-specific issue intelligently and completely. This is one of the major awards given by the Scripps Howard Fund, as it honors what the judges deemed to be the best of local or regional investigative journalism submitted for the year.

WHAT TO ENTER: Work must have originally aired or published in 2022. Entries are limited to 10 items (a day's presentation is counted as one item even if it includes several pieces). Content must be submitted as it originally appeared (with the exception of advertisements). Supplemental material, which does not factor into the 10 item limit, must be clearly marked. Include script(s).

ENTRY FEE: \$75 Entry Fee

PRIZE: \$20,000 and a trophy

SCRIPPS HOWARD FUND

The Scripps Howard Award for Excellence in National/International Investigative Reporting, the Ursula and Gilbert Farfel Prize

WHO IS ELIGIBLE: Nominations may be made by individuals, news organizations or any interested party. Awarded in collaboration with the Scripps College of Communication at Ohio University, this award honors substantive investigative reporting that covers stories intelligently and completely. This is one of the major awards given by the Scripps Howard Fund, as it honors what the judges deemed to be the best of investigative journalism submitted for the year.

WHAT TO ENTER: Work must have originally aired or published in 2022. Entries are limited to 10 items (a day's presentation is counted as one item even if it includes several pieces). Content must be submitted as it originally appeared (with the exception of advertisements). Supplemental material, which does not factor into the 10 item limit, must be clearly marked. Include script(s).

ENTRY FEE: \$75 Entry Fee

PRIZE: \$20,000 and a trophy

SCRIPPS HOWARD FUND

The Scripps Howard Award for Excellence in Multimedia Journalism

WHO IS ELIGIBLE: Nominations may be made by individuals, news organizations or any interested party. This award honors the best use of multiple platforms for storytelling, or coverage of an event or issue. Any combination of media – text, photos, graphics, audio, video – may be used.

WHAT TO ENTER: Work must have originally aired or published in 2022. Entries are limited to five items (a day's presentation is counted as one item even if it includes several pieces). Content must be submitted as it originally appeared (with the exception of advertisements). Supplemental material, which does not factor into the 5 item limit, must be clearly marked.

ENTRY FEE: \$75 Entry Fee

SCRIPPS HOWARD FUND

The Scripps Howard Award for Excellence in Opinion Writing

WHO IS ELIGIBLE: Nominations may be made by individuals, news organizations or any interested party. This award honors outstanding opinion-based journalism by an individual or team whose work was originally distributed in 2022 by a television or radio station, newspaper, cable network, online news site or website, news magazine, news service or news syndicate. This category recognizes editorials, commentary, blogs, editorial cartoons and other forms of journalistic expression.

WHAT TO ENTER: Work must have originally aired or published in 2022. Entries are limited to five items. Supplemental material, which does not factor into the five items, must be clearly marked.

ENTRY FEE: \$75 Entry Fee

PRIZE: \$10,000 and a trophy

WHO IS ELIGIBLE: Nominations may be made by individuals, news organizations or any interested party. This award honors in-depth television/video coverage of a single event or issue that is local in scope. Entries will be judged on general excellence, depth of reporting, quality of storytelling and resourcefulness.

WHAT TO ENTER: Work must have originally aired or published in 2022 and must be entered as presented (with the exception of advertisements). Entries are limited to 10 items (a day's presentation is counted as one item even if it includes several pieces). Supplemental material must be clearly marked. Include script(s).

**The Scripps Howard Award for Excellence in National/International Video Storytelling,
honoring Jack R. Howard**

WHO IS ELIGIBLE: Nominations may be made by individuals, news organizations or any interested party. This award honors in-depth television/video coverage of a single event or issue that is national and/or international in scope. Entries will be judged on general excellence, depth of reporting, quality of storytelling and resourcefulness.

WHAT TO ENTER: Work must have originally aired or published in 2022 and must be entered as presented (with the exception of advertisements). Entries are limited to 10 items (a day's presentation is counted as one item even if it includes several pieces). Supplemental material must be clearly marked. Include script(s).

ENTRY FEE: \$75 Entry Fee

PRIZE: \$10,000 and a trophy
